  - c. Improvements at the baseball and softball fields to include construction of new 30' tall chain link backstops with 30' tall netting; home CMU dugouts with storage room. Visitor dugouts to be chain link fence with sloped metal roof.
  - d. Single bullpens for both home and visitors at each field.
  - e. Two single batting cages with sloped metal roof and lighting for both baseball

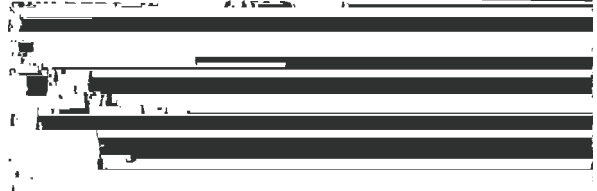
