- I. Overview/History of Department or ProgramPursuant to the Educational Employment Relations Act (EERA), the District and employee organizations shall publicly present their initial proposals related to collective bargaining, which shall thereafter be public records (Government Code§ 3547). The purose of this item is to provide public notice of the District's initial proposals to the Teamsters, Local 150 lated to collective bargaining of a 202023 ReOpener and a 2023-2024 successor agreement
- II. Driving GovernanceGovernment Code section & requires that all initial proposals of the exclusive representatives and the public school employers that relate to matters within the scope of negotiations be presented at a public meeting. It further prohibits negotiation on such proposals until afterthe public has had an opportunity to be informed of the proposal and provide any comments, and the proposal has been adopted by the Governing Hoberd. District's initial proposal is alsow presented to the Board at this public meeting for final approval and 'sunshining.'
