III. BUDGET:

The report itself is first sorted by Purchase Order (PO) typenandber. The first column identifies the PO number. The number thirteen in the PO Number column identifies the fiscal year a<u>\$3</u>207122 following describes the different types of codes used for identifying the type of requisition.

- x B13 = Blanket Ordet used when multiple purchases or payments are made to the same vendor. Thirteen (13) identifies the fiscal year as 2032
- x CHB = Charge Back Blanket Orthesed to reimburse district master purchase accounts, for example such as charging school sides/artments for the district copier rental program.
- x CS = Contract Servicessed for professional, personal or consulting services.
- x J = Justn-Time t used for supply purchases with specific vendors, for example, Office Depot. Items are ordered through a catalog and delivered to school sites/departments within 24 hours. Catalog items are restricted.
- x P = Purchase Ordersunless identified elsewhere, these are regular purchase orders for outside vendors/purchases.
- x TB = Textbook Ordersthis PO typewas established to make sure staff could easily identify textbook orders so they were approved and ordered quickly to ensure students had textbooks by the start of school.
- x N = NonPublic Schoolst used for Special Education Nonublic School contracts.

The next column in the report is Vendor Name. This is the vendor name on file to whom we make payments based on the requisition and final approvals.

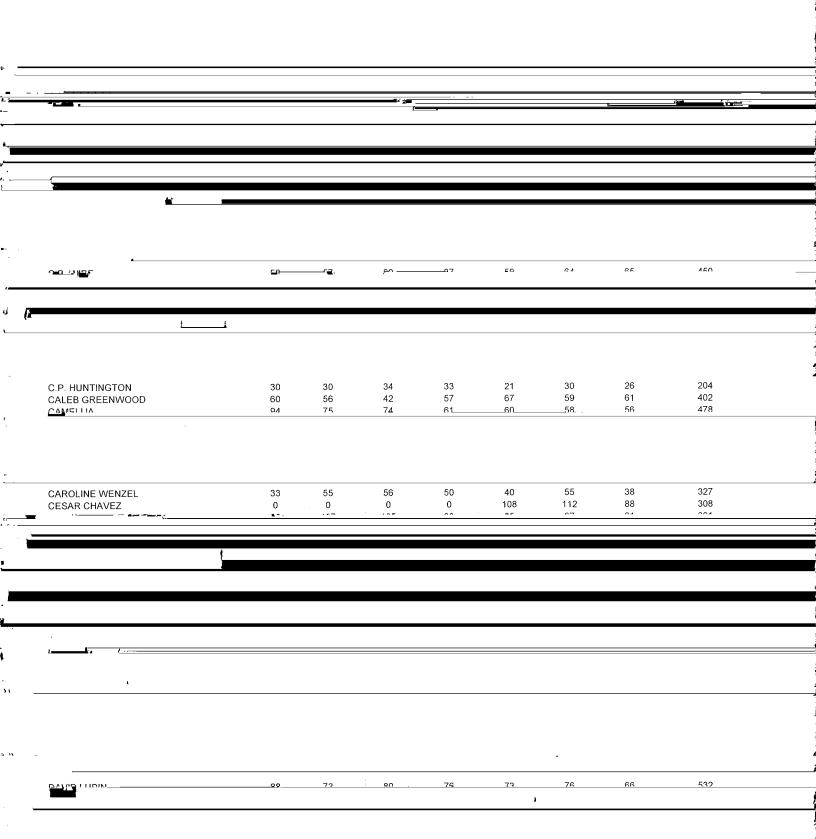

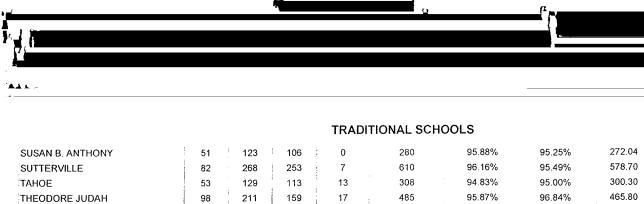
