In 2016, former Superintendent Jose Banda signed an MOU requiring the District to obtain agreement from SCTA prior to implementing any District-wide assessments of students that are not state mandated (hereinafter referred to as "student common assessments," "District common assessments," and "common assessments"). Following numerous efforts to meet with SCTA and reach a consensus regarding student common assessments to no avail, in 2019, the District implemented its system of common assessments and SCTA filed a grievance.
