#### **ACADEMIC OFFICE**

A14-00105 Partnership April 19, 2014 – April 18, 2015: Sacramento City Unified School District (SCUSD) is continuing its transition to the Common Core State Standards in Mathematics (CCSSM). The scope has expanded to all grades, with the grant directly supporting the implementation in Gr. K-8. A condition of the grant is to collaborate with an external technical support provider. As a result of a robust and comprehensive Request for Proposal (RFP) process, the district is partnering with Generation Ready (formerly Editure) Professional Development.

This year, the implementation includes a leadership team of teachers from each school who are participating in a four-part series of district professional learning (October, December /January, March, and May/June). During this time, as a community of practice, they are building their knowledge base, trying out new strategies and methodologies, and reflecting on their own practice, and assisting in expanding capacity at their


