It is simply unheard of to see a district self-certify its budget as Negative when its projected budgets show its ending fund balance in the 3rd year out to be 52 million dollars (almost 4 times what is required by law.)

You said Terri Ryland and Jacquie Canfield over \$190,000 for the first 6 months of

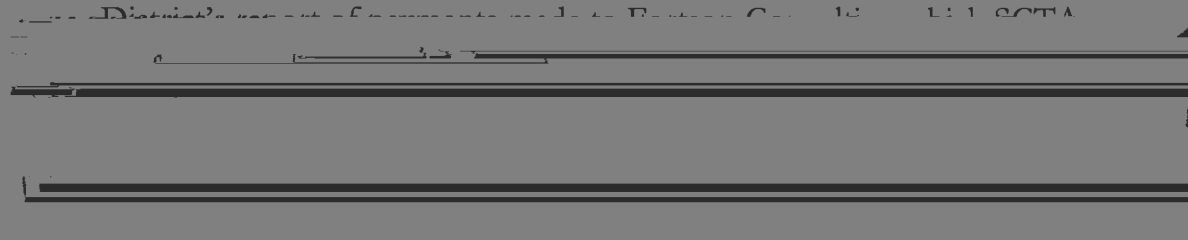
