**RESOLUTION TO ESTIMATE GANN APPROPRIATION
LIMITATION FOR 2013-14**

WHEREAS, the California electorate did adopt at the November election of 1979, Proposition No. 4, commonly

WHEREAS, the provisions of that amendment establish maximum appropriation school districts; and

WHEREAS, the Sacramento City Unified School District must establish a revised Gann Appropriation Limitation for 2012-13 and a projected Gann Appropriation Limitation for 2013-14, in accordance with the provisions of the amendment and applicable statutory law; and

WHEREAS, the Board of Education finds that the proposed appropriations of the 2013-14 budget do not exceed the Gann Limitation;

NOW, THEREFORE, BE IT RESOLVED that the Sacramento City Unified School District Board of Education resolves the following:
