Background/Rationale: May 20, 2012, marks the 75<sup>th</sup> anniversary of the laying of the cornerstone which completed construction of C.K. McClatchy High School in Land Park. Designed by architects Starks and Flanders (who also designed the Elks building downtown) and built through President Roosevelt's Works Progress Administration, the school has remained the pride of its neighborhood ever since opening to students on September 19, 1937.
