Recommendation: Approve nominations, if desired by the Board, to CSBA Delegate Assembly Subregion 6-B (Sacramento County).

Background/Rationale: At its meeting on November 17, the Board appointed President Rodriguez and Vice President Woo to serve as the District's representatives to the CSBA Delegate Assembly.

In addition to these appointments, the CSBA allows school districts, including SCUSD, to nominate candidates to stand for election to the Delegate Assembly through CSBA's Subregion 6-B (Sacramento County). The Board may nominate as many Board members as it desires. Also, the Board may simply pass on the opportunity to nominate members in addition to the previously two appointed Board members. After nominations are submitted to CSBA (the nomination submittal deadline is January 9, 2012 which is why the item is placed on this agenda), the CSBA sends out ballots to all of the Subregion's school districts. The school boards then have an opportunity to vote, in open session, between February 1 and March 15. SCTA's ballots, if cast, are submitted to the CSBA by no later than March 15, 2012. Since there are three positions to be filled at the Subregion level (for a two year term from April 1, 2012 to March 31, 2014), the Board may cast three votes for three candidates. Currently, the nominations are to fill positions that are currently held by board members from Twin Rivers, Natomas, and Folsom-Cordova USD. There is no cumulative voting.
